


Complete this form to calculate your Manitoba small business venture capital tax credit. You can claim this credit if you received a slip T2SBVCTC (MAN.), *Manitoba Small Business Venture Capital Tax Credit*.

The credits you earned in the year are used to reduce your Manitoba tax payable for that year. Any unused amounts can be carried forward for ten years or carried back for three years.

If you are filing electronically, keep all your documents in case we ask to see them at a later date. **If you are filing a paper return, attach this form and your Slip T2SBVCTC (MAN.).**

Carryback to previous years

The carry-back provisions allow you to apply unused credits against your Manitoba tax for the three previous years. The credit you apply cannot be more than your Manitoba tax for that year. The **total** of the credit you carry back to a previous year, and any credit you have already claimed in that year, **cannot be more than \$45,000** and also cannot exceed the total unused credit available (line 9).

If you want to claim a carryback to your **2011**, **2010**, and/or **2009** return(s), send an adjustment request to the Canada Revenue Agency.

Note: Wait until you receive your 2012 notice of assessment before making an adjustment request to your **2011**, **2010**, and/or **2009** return(s).
